

Covid-19	Staff, pupils and handler	Medium	<ul> <li>School to ask Handler to take Lateral flow test before entering school building (as requested for all visitors)</li> <li>Staff and handler to wear appropriate PPE to reduce the risk of transmission of COVID-19</li> <li>Handler to confirm they have not had any symptoms of COVID-19 nor been in close contact with anyone testing positive for COVID-19 before visit.</li> <li>Staff to ensure handler uses hand sanitiser before entering school site and remains socially distanced from other adults where possible</li> </ul>	Staff     Trained therapy dog handler (John Shields)

Bites and scratches	Staff, pupils and handler	low	<ul> <li>All dogs that visit are healthy with no conditions that could be passed on to humans via contact i.e vaccinated, wormed, and treated for fleas</li> <li>All staff and pupils are required to wash their hands after contact with dogs</li> <li>Handlers clear up dog urine and faeces promptly and dispose of this safely - pupils are told to stay away</li> <li>Dogs are not taken anywhere near food preparation areas</li> <li>Dog and handler will have completed therapy dog training to ensure they are safe to be around children.</li> <li>Dog and handler will be insured by relevant charity that they completed training with (Pets as Therapy).</li> </ul>	Staff overseeing visits (tbc)     Trained therapy dog handler (John Shields)

Allergies	Staff and pupils	low	<ul> <li>We will seek individual parental permission for children to interact with dogs</li> <li>Only selected children who are cleared for allergies and have parental permission will have contact with dogs.</li> </ul>	<ul> <li>LF and JWB to ensure that parents of children selected are fully informed of visits and give permission and confirmation of no allergies</li> <li>Staff present at sessions to remain vigilant for signs of allergies in children</li> </ul>
Phobias	Staff and pupils	low	<ul> <li>We tell parents and children about the visit in advance and if necessary, we will provide an initial observation session to watch the dogs at a distance to allay any initial fears,</li> <li>Contact with dogs is optional and staff will choose carefully children that contact would benefit. Parents will have definitive decision about their child having contact with dogs in school.</li> </ul>	<ul> <li>JWB and CW to select appropriate children for visits</li> <li>LF &amp; JWB to ensure that parents of children selected are fully informed of visits and give permission and confirmation of no allergies</li> <li>For those children who may have some initial anxieties, staff to agree an induction visit from a safe distance</li> </ul>

Activities and games involving the dog	Staff, pupils, dogs and handlers	low	<ul> <li>Handler(s) remain with dogs at all times</li> <li>Handler(s) speak to school staff in advance and ensure the area and activity is safe</li> <li>set limit for the number of children who can interact with a dog at once- agreed as no more than 2 children at one time.</li> <li>Handler(s) clean up urine and faeces</li> <li>School staff remove children who misbehave or upset dogs</li> <li>Time limit on activities as recommended by handler(s), so dogs do not get tired or overwhelmed</li> </ul>	<ul> <li>Trained therapy dog handler (John Shields)</li> <li>Staff to ensure they remain vigilant with children visiting and if there are signs of distress or anxiety- and make informed decisions about ending the session early if necessary.</li> </ul>
Children misbehaving	Pupils, dogs and handlers	low	<ul> <li>Children are told in advance what to expect and how to behave</li> <li>School staff are present at all time during the visit</li> <li>School staff are ready to remove children who misbehave or upset dogs or show signs of distress</li> </ul>	• Staff

Damage caused to school materials, equipment and the school site	Dogs	low	<ul> <li>Dogs to wear therapy dog harness</li> <li>Dogs are kept in safe rooms free from too many distractions or outside in a safe/quiet area away from distractions</li> <li>Handlers bring suitable toys if necessary</li> <li>Areas/classrooms are cleared as much as possible before dogs visit</li> </ul>	<ul> <li>Trained therapy dog handler (John Shields)</li> <li>Staff</li> </ul>
